#### STREET BOULEVARD PRUNING

With all the rains the past few years, the vegetative edges of the roads have been encroaching into the driving/biking lanes. It has gotten to the point where it is interfering with user safety.

The city is responsible for clearing these spaces, although, we could use your help. If you want to control what is cut, please cut back any greenery that is within 4 to 6 feet of the roadway. Otherwise, the city will be sending out a crew the second half of September to get after these rogue plants. Thanks for your help and understanding.

### WATER METER UPDATE:

Most cities now have meters read via radio/cellular technology. Our system is archaic—it has become difficult and expensive to get our water meters read. The solution is to upgrade our meters from mechanical meters to electronic. The city is currently soliciting bids for transitioning our homes to this new system. The cost will be paid for by quarterly surcharge until our costs have covered the expense (probably a five year term). More information will be provided in the next newsletter. Stay tuned.

#### **NEW SIGNS:**

You will be seeing fewer signs around town as we have been reviewing which signs are no longer relevant. In addition, our various parks are getting new, uniform signage. We hope you like the improvement.

### MN DEPT OF HEALTH WATER FEE INCREASE

This fee shows up on your water bill as \$1.59/quarter. The fee was established in 1993 by the DPH to monitor and improve drinking water supplies. The fee will be increasing \$2.43/qtr in January per state mandate.

### SENIOR CHORE SERVICES

### NAME THAT PARK

Our city parks have been named after residents who provided exceptional service to our community. Al Bloomquist was our constable and drove most of the kids on the Birchwood School bus. (And as all the kids around knew, he and his wife also gave out Cracker Jacks for Halloween!) Tighe-Schmitz was named after Lucy Tighe, our first woman mayor, and Ms. Schmitz, longtime volunteer city treasurer. Hall's Marsh was named for Mr. Hall who was the city "President" when we were founded. Curt Feistner Memorial Reserve was named for Curt who was in the 101<sup>st</sup> Airborne Division and died in a helicopter training exercise shortly after 9-11.

On the other hand, a study of the city records shows Nordling Park was named in the early 1970s but the name has little historical significance to Birchwood. We are looking to upgrade our park signage, so the council agreed it is appropriate to review the name.

We would like your input on this. Names that have been floated about include: Birchwood Commons, Central Park, and Shank Park—a tribute to the family that initiated the Fourth of July Parade and helped create the Birchwood Painters group and then the White Bear Center for the Arts. When the Shanks sold their home, they required the new owners to continue the start of the parade on their property...as it had for over 50 years.

#### **OTHER BITS:**

- Old signs that are no longer relevant will be coming down. Park signs will be updated and "decluttered". Those new signs will be brown and consistent throughout town.
- The Lake Avenue overlay will soon be progressing. A drainage swale will be constructed along the north side of the hockey rink along with paving the hockey rink parking lot.
- We are working on a multi-use surface overlay for the hockey rink to make it usable for most of the year. Markings for basketball, pickleball, hopscotch and shuffleboard are planned.
- Utility bill ACH direct deposits have climbed to a third of the residents. This creates more efficient processing so there is a \$2 discount each quarter for those who opt in. Sound like you want in? Please contact city hall for more info.

# MAYOR'S NOTES by Mary Wingfield

Earlier this summer, the Roads Committee and City Council held a joint public forum to address the Lake Links connection at the Mahtomedi border and how that will affect our approach to bike and ped traffic around the lake.

There are a number of differing views on the subject. Some want an expanded path through town to accommodate walking and biking, others want no change, and a few want a separate path altogether. We all want a safe and user friendly resolution and we want to ensure the cost is not passed on to our residents.

This is a complicated problem and it will take time to come up with the best solution that addresses these concerns. We have already added stop signs and reduced the speed to 25 MPH along the roadway. This has significantly reduced traffic by pushing faster drivers out to Hwy 244. We have also narrowed the lanes as a "traffic calming" measure.

There are some other things that we can do to improve Hall Avenue:

• Grass and other vegetation have taken root on top of the pavement along the edge--by as much as 6 to 24 inches in places. The pavement needs to be bladed to remove this encroachment. We have been told that this problem is exacerbated when the shoulders are higher than the pavement causing dirt to accumulate on the roadway. Scraping the shoulders down and possibly adding Class 5 material to the edge will help.

• In recent years, large snow accumulations have made plowing the full width of the road difficult. The council will consider having the mailboxes and any other impediments on the south side of the road moved to the north. This will help the plows to keep the road the same width as the summer.

These changes are small, but incremental. It should help the council evaluate how it wants to proceed in the future. We hope you will support these ideas.
