# 2 BIRCHWOOD VILLAGE NEWS A SALTY PROBLEM...

A recent gardening column by Bonnie Blodgett in The St Paul Pioneer Press highlights the issues communities face with icy roads and salt. This has been an especially difficult winter season. With the temperatures fluctuating above and below freezing, ice builds up. This has created nightmares for public works departments all over the area. The problem is exacerbated for us because of our hilly terrain, north facing slopes and heavy tree canopy. Now climate change is expanding the icy season throughout the winter, rather than just the springtime. So we end up applying more salt than ever to our roads.

Salt is a wonder chemical for keeping our streets ice free if the temperature is above 20 F. It loses its efficiency below that. The down side is salt is corrosive and is harmful to plants. Salt dissolves into the runoff water, so it moves through the environment very easily. Research recently found that "in the urban Twin Cities area, 70 percent of the salt applied to roads stays within the region's watershed. Once there, the contamination is difficult and expensive to remove." Every snow event results in about 5 tons of salt being applied in Birchwood. Birchwood and other communities are all affecting the quality of White Bear Lake due to road salt applications.

We will be facing the consequences of our actions for a long time to come. What can we do? We currently use 100% salt to treat our roads. We could opt for a 50/50 mixture of sand and salt, but the effectiveness of melting the ice is reduced and we receive many more slick-road complaints. Ms. Blodgett recommends we all take action on reducing the use of fossil fuels to help us get our climate back under control. Ideally, that is the best solution, but the problem is not going to go away any time soon. Let us know your thoughts.

Meet Birchwood neighbor Elmer Weber! Elmer was born in January 1924 in North St Paul. He is one of 10 siblings. His parents owned a restaurant and boarding house in N. St Paul. Elmer and his siblings helped with the cleaning. It was hard work but there was also play time. Elmer and his family had a home on what is now Bellaire Beach. They would spend summers on the lake. He recalls fishing, swimming and even surfing! He made a "surf board" out of plywood.

Elmer served in the United States Army during World War II. He worked in the Signal Corp hanging telephone wire in Germany between headquarters and the front line. This explains why you can still catch Elmer up on a ladder or trimming a tree!

After the war, Elmer owned a clothing and shoe store in N. St Paul. He ran the store until 1996 when, at the age of 72, he officially retired. When asked how his small business survived the big box stores, his answer-"volume. I just knew if I kept my margins down, I'd keep my customers coming." He had many loyal customers- some from as far away as California!

Elmer has hunted and fished all around the world. One of his favorite trips was fishing for Peacock Bass in South America. He continues to be an avid fisherman today. Elmer is our go-to for wildlife questions. Last spring he shared the discovery of baby owls in his backyard. His skills are endless. He has an engineer's mind-- if he needs a gadget, he builds it! He has made a portable ice fishing house, anti-squirrel birdfeeder, and other useful things. It isn't unusual to see him tinkering in his garage. We have him working on a deer deterrent now!

As his neighbors, we appreciate his service to our country, his keen knowledge of wildlife and nature and the kindness he shows us.
