### DOG LICENSE RENEWAL

It's time to renew dog licenses again for another two-year permit period (Jan 2020 – Dec 2021). Licenses must be renewed by Jan 15, 2020. See application on the last page.

#### \$25 WATER BILL SURCHARGE

We have been limping along with our current meter reading contract and are reaching the end of an era. Currently, a person walks the village with a hand held reader and points it at every meter in town. That means that person has to make it through snow and walk around homes and spend the better part of a day doing this work. The company has been reluctantly providing the service and has been continually raising its rates to give us incentive to upgrade our system. That time has come in

light of the technology of the 21<sup>st</sup> century. In addition, our utility advisor recommends that we upgrade our water meters at this time.

The city has obtained bids for this improvement. The cost for the transition is up to \$145,000. Accordingly, the council recently approved a \$25 quarterly surcharge as a result. That surcharge will sunset when the expenditure has been recovered (approximately four years)

# PLEASE KEEP YOUR CATS INSIDE

The recent deer hunt has generated a number of comments. One of those was a concern about other wildlife welfare: cats spending time at neighbors camped below bird feeders killing the birds. #### **GWBLF GRANT**

Birchwood was awarded \$2000 for help in creating a multisport, multi-season court over the hockey rink base. ### SPECIAL ASSESSMENT TOWN HALL MEETING

The City Council will be holding a town hall meeting for all Birchwood residents on Thurs Feb 6, 2020 at 7pm to discuss how residents wish to pay for road work going forward. The outcome of this meeting will determine how the current Lake Avenue road project and all future road work is paid for. The two options being considered are:

- 1) to assess only the properties that receive an increase in property valuation from the work, and
- 2) to levy all residents for all city road work through property taxes.

With the first option, residents will only pay when work is done to their streets and the amount will depend on the appraised value that the project has on the individual property. With the second option, all residents will pay for all road work citywide and the amount will be based off of the individual property tax rate.

All residents are encouraged to attend. **Please come ...** and bring a neighbor with you. In the alternative, you may reach out to the mayor/council members or city hall with your thoughts.

## 2020 TAX LEVY

By now you have received your proposed taxes for the next year. The city levy increased by about 34%. This is a large increase. Bear in mind, the city's portion of your tax bill is about 25% so the overall effect is a city tax increase of about 7%. Your values may differ somewhat due to the peculiarities of tax rates relative to property valuation. Keep in mind property values have increased overall. Also remember the school bond referendum increase was not included in your estimated tax statement.

The main culprit for the city's increase is the recent construction you probably noticed at the base of South Shore Blvd. That was our project to remove the Birchwood Lane lift station and coordinate with White Bear Township and use their nearby lift station for a handful of residents on Birchwood Lane. The city council was appraised a year ago that the old lift station was broken, obsolete and not repairable. This new, efficient solution was not cheap (\$420,000) but still less than the cost of replacing the current structure (\$500,000). And we will no longer have to pay for repairs, maintenance, and electricity, nor will we need to arrange for generator back up since gravity works 24/7/365.

This additional \$100,000 per year tax increase will sunset in four years when the costs of construction have been recouped. The city also put in an emergency grant request to the legislature. We are hopeful that the legislature will support us with this unexpected, emergency expense. We will cross our fingers and keep you posted on the status of this grant request.

## **MAYOR'S NOTES:**

Last month the city council awarded a contract for a new property assessor. The change was made because the council wants accountability and valuations that are in keeping with the market. In the past five years, the overall city values have experienced double digits increases then flat growth followed by large increases again. This is not in keeping with the real estate market when the reality is growth has been more gradual and consistent. These more dramatic rises have caused our residents to pay higher county and school taxes relative to our other communities while we wait for them to catch up to our increases.

The change gives residents the opportunity to communicate directly with the appraiser at our city hall through a Board of Review (which the city council sits as). This gives the city council the opportunity to monitor our valuations. In the end, the goal is to ensure all residents are heard and treated fairly in the process.

Licenses are for two years and are issued in even-numbered years. Newly-licensed dogs in odd-numbered years are charged 50% of the two-year fee. The license will be mailed to you upon receipt of your application/fee. The license must be put on the dog's collar by January 15, <u>2020</u>.

The license fee is \$20.00 per dog and will be good through December 31, <u>2021</u>. The late license fee will be triple the regular fee if the license is not purchased by February 15, <u>2020</u>. Failure to obtain a license by February 15<sup>th</sup> could result in a court summons. Licenses are required for dogs 6 months of age and older.

City code requires that all dogs must be restrained 12 months of the year.
