That flat water fee increases \$10. This fee covers the expenses for maintaining our water system, including breaks. There are no increases on sewer rates.

# A COMPARISON OF YOUR TAXES

As noted at the beginning of this Newsletter, your city taxes are going down 3.5% next year. Last year the city tax change was 0%. By comparison, the Washington County levy is increasing 4.9% next year, after increasing 5.68% in 2022.

The Birchwood City Council continues to use Larry Walker's Zero Budget process that has guided us so well over the years. We have no commercial property and virtually no growth, so we also have been seeking grants to supplement our income. (See story below.)

Doing a side by side comparison with other cities is helpful. In Mahtomedi a \$400,000 house is assessed about \$1300 in city taxes. In Birchwood, that same house is assessed about \$850. Of course, cities can impose other, direct taxes such as assessments —something that Birchwood has shied away from in the last decade. The city council has been working hard to ensure we are using your tax dollars efficiently. We hope you agree.

[One other bit: when you get your property tax statement, most of your taxes go to the school district. So your taxes may be going up, but it won't be because of city taxes.]

# WILDWOOD LIFTSTATION FUNDING UPDATE

As we head to press, we are still awaiting the status of the US Appropriations bill for FY 2023. Birchwood, along with 14 other entities, is in line to share \$35 million dollars. Representative Betty McCollum guided our request for our \$480,000 lift station rebuild through so many hurdles. This fall we made the final cut from a list of 70 proposals. One would think that positions us well for final approval, however, we are at the mercy of the Senate and its filibuster. The absolute deadline to get this done is December 31<sup>st</sup>. After that, our pumpkin comes and we start over. (i.e. It won't happen given the Rep Betty's party will be in the minority.) Watch the city website for updates.

#### HIGHLAND/BIRCHWOOD PATH PLAN

Coming this spring! Look for this new path to give you an option to veer off Hall Ave for a quiet, short jaunt into the woods before popping out at the end of Birchwood Ave. The city council recognizes residents are supportive of public pathways. Our Comprehensive Plan provides guidance to ensure minimum impact to the neighbors. This route has had significant residential turnover recently. It also has the support of the one property owner who is most directly impacted. Given this unique set of events affecting the fewest residents, the city has approved opening up this public space. (FYI, there will be no extension into Mahtomedi or over to White Pine Ln.) The trail will keep a small footprint. Signage will be placed at both ends. Some deadfall and brush needs to be moved. We are looking for volunteers to assist this spring. Please contact the city clerk to sign up. No skills or tools necessary, except a desire to be part of our next park!
