WATER INCREASE SURCHARGE

Due to several breaks, a \$25 water main break surcharge will be added to all quarterly utility bills to help recoup the cost of the repairs until the water fund is replenished.

TENNIS SANITATION RATE INCREASE

Tennis Sanitation has informed the city they will have a rate increase beginning January 1, due to an increase from the Ramsey/Washington Recycling & Energy Center (R&E Center) which will affect monthly rates.

ADOPT A HYDRANT OR DRAIN THIS WINTER

Please watch hydrants to make sure they are free from snow and ice with 3 feet clear to help keep our community safe. Also please clean leaves away from storm drains or roads to prevent them from going in the lake. Thank you!

DOG LICENSES REQUIRED

The Parks & Natural Resources Committee wanted to send along a few announcements and reminders for everyone as we all transition to the colder months.

First, a reminder that the **hockey rink** will be opening in December - weather permitting - please keep an eye out for an official announcement from the city for the exact date and hours of operation.

Second, the Birchwood City Council recently amended the city ordinances banning motor vehicles from beach access easements. As such, the easements should not be used for snowmobiles or other motor vehicles to access White Bear Lake.

Finally, we would like to remind everyone that everything we place or pour on the ground ends up in the lake. Please consider reducing the use of salt when practical or even switching to a bio-friendly ice melting product that is much safer for the environment. PREVENT POLUTION IN OUR WATERWAYS

BUDGET UPDATE

The City Council has been working on the proposed City Budget for 2024. A few residents have shared their thoughts about the budget draft presented in the past four City Council meetings. I invite all who have questions to review the budget and reach out to me to discuss concerns or ideas. Or, you are very welcome to attend the Council meeting on December 12th.

In the preparation of the budget, we looked at past expenses and created projected 2024 expenses and initiatives. We are mindful of the property tax expense for the community and have tried to make the budget both realistic and focused on essential expenses to run the city. I'd like to highlight two major initiatives for 2024 that are needed infrastructure expenses. 1) We have a sewer lift station project which is in part funded by a federal grant and money from the Rice Creek Watershed District. We have budgeted our share of the project expense completely to fund this project in 2024. 2) We are in the process of creating a new road improvement plan and have budgeted funds for the first phase of road repairs in 2024.

GENEROSITY & INSPIRATION: THE WORKDAY UPDATE

We had a successful city wide clean up day on November 18. The workday included picking up trash, cleaning the City Hall kitchen, clearing buckthorn, chain sawing up the big fallen trees along (some of) the City Right of Ways and Parks and clearing and painting the hockey rink. Great progress was made and please join us at the next one. Many hands make light work!

A very special thanks is due to Dan Bailey of Minnesota Grown Services. He is in the village doing a boulder landscaping project and had unloaded his boulders from his really big, heavy-duty trailer. He saw the work being done and asked the volunteers if he could donate the use of his trailer to haul away a full load of wood and brush! He generously said, "I've got an empty trailer and will dump it for you, if you'd like to fill it up". In addition, he swung by Grotto and helped David and Kathy load the 12-150 lb tree stump cookies ready for disposal. His payit-forward generosity and strong back is both inspiring and warmly appreciated!

Please join me in thanking the clean-up day leaders, Jim Rydeen and Ron Koehne from our Birchwood Maintenance team. And three cheers and thanks to our community of volunteers listed on the front of this newsletter!
