 - a. Allocate 1-2 hours with the city engineer to recommend road safety measures.
 - b. Allocate a temporary speed bump at 170 Wildwood Avenue to assess the decrease in traffic speeds.
 - c. Allocate temporary stop signs and a cross walk at Owl and Wildwood Ave to slow traffic and allow for safe pedestrian traffic and crossing.
 - d. Consider the city wide 20 MPH. The west section of Wildwood Ave is 25 MPH, and as one travels east it's 20MPH. Hall/Cedar Ave is 25MPH, and traveling to and from Mahtomedi the speed limit is 20MPH.

- Meeting opened at 7:05 PM
- Present at the meeting
 - Ron Malles, Cora Hankins, & Art Arsenault
 - Not present: Margaret Ford
- Open Forum with citizens and Washington County Law Enforcement
 - John Berg, Ryan Hankins, Shari Hankins, Allison Bulolf, Mary Sue Simmons, Don Hankins, Sgt. Mike Pearson, Deputy Ryan Corniec
 - Cora explained the Task Force's purpose and history
 - Data from three (3) speed studies was review and discussed
 - two studies on Wildwood and one ongoing study on Hall
 - The Task Force shared the first proposal to adopt a 20 MPH speed limit city wide.
 - No opposition to this was aired.
 - The Task Force shared the second proposal to add two Crosswalks on Wildwood Ave
 - No opposition to this was aired to adding the Crosswalks
 - Discussion on signage yielded valuable inputs
 - Do NOT add Stop signs
 - Crosswalk warning signs thought to needed because of visibility issues
 - Road Centerline signage was suggested
 - Both the Sgt and Deputy agreed these signs reduce speeds in these areas as they have seen in the Mahtomedi community.
 - Other suggestions from group was a need to address the lack of drivers stopping at numerous Stop signs.
 - It was noted by Washington County Law Enforcement.
 - Speed Bumps, Rumble strips and other features discussed
 - Possibility of a raised formal crosswalk along Wildwood Ave. (@ the two new crosswalk locations) and Hall Ave (@ White Pine Lane).
 - Suggestion was made to replace faded signs with new ones
 - Ron was given Bob Gobel's name to contact for signage sourcing. Bob works for Mahtomedi public works.
- Next Meeting set for Thursday July 4, 2024 was NOT scheduled pending City Council inputs to the two proposals and because of the holiday.
