

# Birchwood Lake Links Bike trail Minutes Wednesday, March 27<sup>th</sup>

- A. Introduction of new and current members
- B. Much discussion occurred around concerns about bike, pedestrian and motorist safety; bike trail routes; respecting property rights of owners; positioning of bike/pedestrian lanes; and fine gravel vs pavement for bike lanes.
- C. Three guidelines were put in place to decide bike routes and lanes:
  - 1. Safety- of bikers, walkers, pedestrians and motorists
  - 2. Feasibility- cost of road changes, signage, and road markings
  - 3. Usability- of all persons
- D. Three routes were chosen for trail consideration, starting from Mahtomedi:
  - 1. Hall Avenue west to right on Cedar Avenue to Left on Wildwood Ave.(current route of bikers).
  - 2. Hall Ave west to right on Jay Street to Lake Avenue, to west on Wildwood Avenue.
  - 3. Hall Avenue west to continue on Cedar Ave. to right on Birchwood Avenue to right and north on Century Avenue (current route of walkers)
- E. Plan for a community meeting in future to present and allow discussion on prospective changes
- F. Members, please bring pros and cons of each prospective route to next meeting

# Birchwood Village Lake Links Trail Task Force Minutes -- April 24, 2024

Attendees: Mary Cahill, Ben Creagh (had to leave early), Karen Freeberg, Bryan McGinnis, Mike Werner, Jane Warnet.

Since the Chair and Secretary could not attend the meeting, the "pre-meeting" discussions simply evolved into free flowing "meeting" talk, with little regard for the agenda. Since everyone recognized that we were making progress, we continued on this way with emphasis on items 4 and 5 of the published agenda.

Thanks to Ben for the information/recommendations that he sent out to us before the meeting. We took no action on the improvements listed. They should be considered when a preferred route is selected.

Karen reviewed the street pavement measurement data that she and Cora took. Widths vary from street to street and along individual streets.

Most of our time was spent on Item 4. of the agenda: Pros/Cons of three possible routes. :

a. Hall Avenue west to right on Cedar to left on Wildwood to East County Line

<u>Pro</u> <u>??</u> <u>Con</u>

shortest route relatively high traffic on Wildwood

no steep hills garages on Wildwood are close to pavement

a little shoulder on Hall parking on Wildwood especially in summer

children often on or near pavement on Wildwood

b. Hall west to right on Jay to Lake to west on Wildwood

Pro ?? Con

closest to lake and parks

a little shoulder on Hall longer route

parking on west Wildwood/Lake esp. in summer

relatively high traffic on Wildwood

children often on or near pavement on w. Wildwood

Hazardous corner at Jay & Wildwood

Steep hill on west end of Lake to Wildwood

c. Hall/Cedar west to Birchwood to right north on East Cty Line to join present trail

Pro ?? Con

lower trafffic vs Wildwood hill on Cedar to Birchwood

no garages close to pavement more of route on higher-traffic Hall/Cedar less parking issues safety vs. higher speed traffic on ECtyLine

safety vs. higher speed traffic on ECtyLine need some construction to optimize safety

Option C was preferred by consensus with no formal voting. Safety issues seemed to dominnate our discussions. Please read Ellen Maas' submitted comments that support and amplify the Pros & Cons summarized above. Having the path from Birchwood

Ave to Wildwood (Cty F) on the west side of ECtyLine was proposed since this side has a shallower ditch. If and when any improvements to ECtyLine are planned, it could be an opportunity to put in much better "trail".

It is thought that the Lake Links mission is to encourage both walking and biking on the same route.

A fourth option with a route off Hall up White Pine and through Polly's Park to Birchwood Ave. was not considered feasible because of poor condition of the existing path through Polly's Park and the longer route.
